Q-When is garbage Picked-up?

A—Garbage is picked-up every Wednesday morning. You must have your garbage container out at the roadside by 5:00 AM on collection day. We advise you put it out on Tuesday evenings, (after 6:00 PM). The lid opening should face the center of the road.

Q-When do I need a building permit?



A—When your building will exceed 120 square feet, if you are making any changes in a building which will, or might, jeopardize the structural integrity of the building. If you don't know please call.

Q—Do I need a permit to install a fence?

A—Yes, You must obtain a permit before you construct your fence. You can get an application at Town Hall. Public Works will process your application within three business days.

Q—Am I required to license my dogs?

A—Yes, all dogs owned by persons living within town must be licensed. You will need a rabies vaccination certificate from a Veterinarian before we can sell you a license for your dogs.

## Town of Mattawa Ordinances

#### Junk and Weeds

The owner and or the occupant of all property in the town shall remove all debris, junk and rubbish such as old and unused vehicles, machinery and equipment of all kinds. You must also keep any driveway and alley adjacent



to the property clean. You must remove all grasses, weeds and shrubs which are a fire hazard. Failure to keep your property clean will result in fines up to \$950 per violation.

#### **Noise**

Public noise disturbances are prohibited. The town council wishes to control the level of noise in a manner that promotes enjoyment of property, sleep and the quality of the environment. Any sound from audio equipment that can be heard from a distance of 50 feet is prohibited. The first violation for noise is \$100 Second violation is \$300 third violation is \$500.

#### Animals

The keeping or raising of animals except domestic household pets is prohibited within the town limits. All animals within the Town of Mattawa must have a license. The license fee shall be in the sum of ten dollars per year for neutered male dogs and spayed female dogs, and fifteen dollars per year for non-neutered male and non-spayed female dogs and will not be licensed without proof of rabies vaccination.

It is unlawful for any owner to permit dogs to run loose on the public streets, public places or on private property owned by another person without the owners permission.

Pit bull dogs and/or pit bull mixed dogs are considered potentially dangerous animals and are not allowed within the Town except with certain restrictions. The owner must register the animal as potentially



dangerous with the Town. The owner must present proof of a proper enclosure and provide a surety bond in the amount of fifty thousand dollars

insuring the owner for any injuries inflicted by the potentially dangerous dog. The owner shall pay a fee of \$25 in addition to the regular license fee.

## Interpreters for the Police Dep.

The City of Mattawa Police Department has adopted a limited English plan to assist the residents of Mattawa to bridge the communication gap. Interpreters are on staff and available for police Spanish language needs.



#### Business License

Any person conducting business within the Town of Mattawa is required to obtain a business license.

The fee for a license is \$30, from January 1st to December 31st. The fee for a license issued after June 30th is reduced by 50%. Fees are subject to annual review.

### Killing and slaughtering of animals

No person shall kill or butcher any animal or fowl within the town of Mattawa Any person violating any of the these laws shall be guilty of a gross misdemeanor and shall be punished by a fine not to exceed \$500.

### Parental Responsibility

No parent shall allow his or her child to remain in, on, or occupy any area of public streets, roads, alleys, parks, playgrounds, or any other public grounds, places of amusement, places of entertainment, commercial businesses between the hours of ten p.m. and five a.m. on weekdays and twelve midnight and five a.m. on weekends, except as allowed below.

Exemptions: A child with his parent. A child engaged in work. A child on an errand for his parent. A child involved in an emergency concerning the person or property of himself or another. A child returning home from school sponsored or church sponsored activities, or from other activities supervised by an adult. The term returning home means immediately and directly after participation in such activities without broken chain of sequences and time between the end of such event and the time such child returns to his or her residence.
